

The performance highlights of the Department of Heavy Industry for the month of April, 2011:-

I Bharat Heavy Electricals Ltd. (BHEL)

Order booking:

During April BHEL received orders worth **Rs. 1,164 Crs.** out of which :

✚ Power sector has booked **orders worth Rs. 48 Crs.**

✚ Industry Sector has booked **orders worth Rs.1,116 Crs.** which include orders from ONGC Petro Additions Ltd. Gujrat for Captive Power Plant (4xFr 6B GTG + 4xHRSG) worth Rs.930 Crs, Wet Gas Compressor & Heat Pump Compressor from IOCL, Mathura and 40 Sets of 25 KV AC-EMU Electrics(Conv.) from RCF Kapurthala.

II NTPC-BHEL Power Project Pvt. Ltd. (NBPPL)

- NBPPL has finalized the accounts for the year 2010-11 and achieved a Gross Turnover of Rs. 110 crore, including other income (Audited) during the year against the MoU target of Rs. 90 crore.
- The company has achieved a profit (PBT) for Rs. 16.22 crore (Audited) against a MoU target of Rs. 4 crore.

III. National Automotive Testing and R&D Infrastructure Project (NATRIP)

NATRIP Implementation Society (NATIS) constituted for implementation of National Automotive Testing and R&D Infrastructure Project (NATRIP) envisaged setting up of world class automotive testing and homologation facilities at seven different location of the country with a total investment of Rs. 1718 crores in six years period. The Cabinet Committee on Economic Affairs in their meeting held on 28th April, 2011 has approved the revised time lines and escalation of cost estimate of the project. Accordingly, now the revised cost estimates would be Rs. 2268.06 crore with project completion date on December, 2012.

IV Auto Sector

- The meeting of the Indo German Joint Working Group (JWG) on Automotive Sector was held on 18.04.2011 in New Delhi. The meeting was jointly inaugurated by Hon'ble Minister (HI&PE) and Dr. Peter Ramsauer, Federal Minister of Transport Building & Urban Development Germany.
- Cabinet in its meeting held on 31.3.2011 has approved this Department's proposal for setting up of National Council for Electric Mobility (NCEM) and National Board for Electric Mobility (NBEM) for mission mode approach to expand electric mobility and manufacture of electric vehicles (including hybrids) and their components in India. Further action to implement the Cabinet decision is being taken in this Department.

V Performance of major PSEs

A brief tabular statement on the performance of some of the major PSEs under the Department of Heavy Industry is enclosed at Annex-I. The production of these companies' during April 2010-March 2011 was 24.56% higher as compared to corresponding period last year.
