

The performance highlights of the Department of Heavy Industry for the month of February, 2012:-.

I Bharat Heavy Electricals Ltd. (BHEL)

Order booking:

The total order receipts in the current financial year up-to February, 2012 has reached a level of Rs. 18,278 Crore. Significant orders received during the month include:

➤ **Industry business Sector:**

III Auto Sector

1. The Department is in the process of preparing a National Mission for Electric Mobility Plan. In this regard, the 2nd Meeting of the National Board for Electric Mobility (NBEM) was held on 03.01.2012 under my Chairmanship. In the meeting three Working Groups (WGs) have been constituted in the areas of Demand & Supply, R&D and Infrastructure. The three working groups (WGs) have examined and deliberated on the micro details and proposed specific recommendations for the consideration of the National Council for Electric Mobility (NCEM) to finalize the specific issues that can readily be incorporated in the National Electric Mobility Mission Plan 2020 (NEMMP 2020).

IV Performance of major PSEs
